

White Mountains Comments on Impact of Hurricane Charley

HAMILTON, Bermuda, Aug. 23 /PRNewswire-FirstCall/ -- White Mountains Insurance Group, Ltd. (NYSE: WTM) announced today that its preliminary estimates indicate that its total pre-tax net losses resulting from the impact of Hurricane Charley on its insurance and reinsurance operations will be less than \$45 million. These estimates do not include claims incurred by Montpelier Re or Olympus Re.
